What is Commercial law? There is no established definition of Commercial law. In his Hamlyn Lectures, Professor Goode acknowledged that Commercial law has traditionally been treated as a mere aggregation of specific subjects such as sale, agency and negotiable instruments, each a self-contained field governed by its own distinctive rules. Is there a problem with the specific-contract approach? The shortcomings in the specific-contract approach to the teaching of commercial law were highlighted by Professor Roy Goode in a memorial lecture for the late Professor Clive Schmittoff delivered at the Annual meeting of the Association of Law Teachers in Nottingham on 4th April. First, the vast majority of commercial transactions are based on standard form contracts where the terms are not individually negotiated. The codification of English commercial law Although English lawyers have generally resisted the idea of codification,¹³ in the late 19th century businessmen succeeded in convincing Parliament to codify some key areas of commercial law. Although the Sale of Goods Act was re-enacted in 1979 and the Act was further amended in 1994, it remains largely as Sir Mackenzie Chalmers originally drafted it. Whether this 19th century codification meets the needs of the 21st century is a matter of debate. External influences on English commercial law There are two external influences on the development of English Commercial law. First, British membership of the European Union and, secondly, the influence of international conventions aimed at the harmonisation of international commercial law. In establishing the Commission, the General Assembly recognized that disparities in national laws governing international trade created obstacles to the flow of trade, and it regarded the Commission as the vehicle by which the United Nations could play a more active role in reducing or removing these obstacles. The Convention entered into force on 1 January 1988 and currently has 79 parties. The hostility of English lawyers to codification has ensured that, to date, the United Kingdom has not ratified the CISG but this may change. The United Kingdom intends to ratify the convention, subject to the availability of parliamentary time. There have been delays in the past for a number of reasons, but we propose to issue a consultation document in the course of the next few months to examine the available options. We will address the changes that this Bill is likely to entail during the seminars. Studying Commercial law The University of Sussex takes the view that one credit should require 10 hours of study.
