The 46th Virginia Volunteer Infantry Regiment was an infantry regiment raised in Virginia for service in the Confederate States Army during the American Civil War. It fought mostly in Virginia and the Carolinas.

There are both original materials from the Civil War and secondary materials gathered by the Secretaries of Virginia Military Records or the Adjutant General.

This regiment was mustered into the United States service in Sept. The companies were mustered out at Springfield, Mo. The Union Army, vol. Alsup, Forty-sixth Missouri Infantry. I have the honor to state to you, general, that on the morning of the 6th I started a detachment consisting of twenty-three men, under command of Lieut. We found in their possession one Savage revolver one single-barrel shotgun. They all had bountiful supplies of subsistence, which we effectually destroyed. Our pickets were fired on the same night but with no effect. On our return on the 8th we were fired on from the brush by one man. Owing to that region being infested by straggling bands of guerrillas I shall start another scout immediately. David Anderson K, Capt. Chamberlain was Acting Adjutant The casualties of the regiment were: Total, 7 killed, 21 wounded, 82 missing. The casualties named in front of Atlanta occurred August 4, when the Forty-sixth, under Colonel Clark, constituting the main picket line of the brigade, charged the enemy and drove him back, regaining our position against heavy force, and taking 21 prisoners. Colonel Clark had occupied the ditches with his regiment and of the dismounted cavalry, in all , the night of August 2, and his advanced vedettes were driven in August 4. In his charge Clark was supported by another Mississippi regiment. During this campaign Major Rea commanded the detail of sharpshooters until mortally wounded near the Chattahoochee River, July 9. This place was defended by three redoubts and a star fort on the ridge at opposite sides of the cut. French attacked and a bloody struggle followed for three or four hours. He was an excellent and gallant officer. Total of the regiment, 18 killed, 26 wounded, 56 missing. Magee, commanding the Forty-sixth, was among the wounded before the works were reached. Some were able to reach the ditch in front of the works, where they remained until next morning, when the Federal troops were withdrawn. Among these "foremost of the forlorn hope," were the following of the Forty-sixth: Nicholas Pace, Privates C. Screws wounded Company F-Capt. Harvey wounded severely at main ditch , Private J. Drummond w , S. Windham w Company H-Private J. Burgess wounded twice severely near main ditch. There were only five men of Company C left at the time of this battle, under Sergeant Blakeman. The remnant marched to Nashville. December 9 the brigade effective was men. It was found impracticable to bring him out, so he was left near Pulaski. Captain Henderson and Lieut. I was slightly wounded in the foot by a shell. Major Freeman wrote, January Great numbers are going home every day, many nevermore to return, I fear. Nine-tenths of the men and line officers are barefooted. Chalmers wrote, in his journal, January All are ragged and dirty and covered with vermin. There are, twenty guns, but not a single cartridge box in the regiment. The men are jovial enough regarding their condition, but when one speaks of the prosecution of the war, they are entirely despondent, being entirely convinced that the Confederacy is gone. Captain Heslip, of Company E, is in command of the regiment. I do not think there is a stand of colors in the brigade. Adair, the Forty-sixth Regiment commanded by Capt. General Steele, commanding the Union expedition from Pensacola, reported that on April 1 an outpost four and a half miles in front of Blakely was carried by assault and the battle-flag of the Forty-sixth Mississippi and 74 prisoners taken. This was about half the regiment. When Fort Blakely was captured, April 9, , another portion of the regiment became prisoners of war. They were taken to Ship Island and paroled in May. The regimental camp was established on the banks of the Neuse River near the city.
