They would not give me answers on the phone. Authorities need to look into this company. Any matters falling within a lapsed period of time are not fully covered by the membership. Fortunately, we have the preferred member discount which was offered and declined according to our records. The issues are always non covered and a fee or referral required at a so called reduced rate. Later it became universally known as LegalShield. You can use Avvo. You will also receive referrals if necessary. LegalShield works best if you are using it to protect yourself against minor traffic infractions or have them write a letter as a scare tactic. Several times I have received errant advice from their attorneys. Right now, I have been sued based on faulty advice an attorney for the local provider firm provided and I acted on. I contacted corporate regarding the issue and they deferred the final say on the matter to the law firm that provided the faulty advice to begin with.

Commissions on average go to 8 other people on a sale. You have to pay extra for contracts greater than 15 pages in length. Letters and Phone Calls: Criminal moving violations and unmeritorious cases are excluded. Commercial vehicles with more than two axles are not covered. Dependents covers member and spouse only. Bankruptcy, divorce, separation, annulment, child custody or other divorce or domestic-related matters. Lawsuits filed because of something that occurred prior to the membership or because of conditions that were reasonably anticipated or foreseeable prior to enrollment even if the lawsuit is filed after enrollment. Garnishment, attachment or any other appeal. Coverage includes the return due on April 15th of the first membership year. Hourly rates for referral lawyers and court appearances may vary. Members may use their preferred member rate and phone consultation benefit for Plan exclusions. A retainer fee may be required prior to services being rendered for services not otherwise covered by membership benefits. Then they refer you to an outside lawyer who you will need to pay additional money to. They continue to charge your credit card monthly without permission and they make it difficult to contact them. It creates a world were you can access an attorney and then pay a lot of money to do something about your legal issue. There are many complaints about the LegalShield service. Their handling of the case is null and will make you waste precious time. Stay away from LegalShield and find a decent lawyer there must be some.. They have many complaints over the last 12 months. Did not make corrections as requested 3 times 7. Unfortunately, almost half of all consumers cancel their service before the year ends. When this happens, the company takes back part of the commission the associate was paid leaving an associate earning considerably less than they had expected. This structure rewards those with a large team but often leaves those just getting started struggling to earn enough to support their business. Many levels of compensation only further enriches those at or near the top of the pyramid of distributors. Excessive levels in a downline is another sign participants are expected to sell primarily to their downline, rather than to the general public. This makes it an exploitive money transfer scheme, or product-based pyramid scheme. It is focused on recruiting an endless amount of people to become associates which purchase the plan to remain vested, and the focus is not on retail sales to customers. The product has some very serious quality issues with the amount of complaints that are found about the service. On average commissions paid are divided between 8 people.
