The form enables the SEC to register investment advisers and to obtain information from and about exempt reporting advisers Every applicant for registration with the SEC as an adviser, and every.

It depends on certain statutory criteria. If the investment adviser does not meet SEC statutory criteria, the investment adviser must be registered or licensed by a state, unless otherwise exempt. Any person who wants to become an investment adviser in California may apply for a certificate by filing an application. The forms and instructions for filing an application are found on our web site. To file electronically with IARD, the applicant will need to obtain, complete and return the entitlement forms. These forms may be found on the IARD web site at [www.iard.org](#). Fees are not refundable except as provided in Government Code Sections 60000-60009. The filing fee does not apply to any applicant that is also Licensed as a broker-dealer under Code Section 60000. A synopsis of the information that may be found in this page is as follows: This fee must be paid directly to IARD in accordance with its instructions. The annual renewal program begins in November of each year with the annual renewal payment due to IARD in early December. The annual renewal fee does not apply if you are also Licensed as a broker-dealer under Code Section 60000. This annual updating amendment should be filed with IARD within 90 days of your fiscal year end. It is important Form ADV contains current and accurate information. The annual financial report is to contain a balance sheet and income statement that must be prepared in accordance with generally accepted accounting principles. If you only have discretionary authority over client funds or securities, the financial statements need not be audited. A verification form must accompany the financial statements. The verification form a must affirmatively state, to the best knowledge and belief of the person making the verification, that the financial statements and supporting schedules are true and correct and b must be signed under penalty of perjury. This form should be completed in accordance with the form instructions and mailed to the address as found in the instructions. 2: Umbrella Registration – Compliance Building

Form ADV is the uniform form used by investment advisers to register with both the Securities and Exchange Commission (SEC) and state securities authorities. The form consists of two parts. Part 1 requires information about the investment adviser's business, ownership, clients, employees, business practices, affiliations, and any disciplinary.
