The twenty-first century will be different. China and India are emerging as economic and political heavyweights: The National Intelligence Council, a U. Such growth is opening the way for a multipolar era in world politics. This tectonic shift will pose a challenge to the U. At the behest of Washington, these multilateral regimes have promoted trade liberalization, open capital markets, and nuclear nonproliferation, ensuring relative peace and prosperity for six decades -- and untold benefits for the United States. But unless rising powers such as China and India are incorporated into this framework, the future of these international regimes will be uncomfortably uncertain. Given its performance over the last six years, one would not expect the Bush administration to handle this challenge terribly well. After all, its unilateralist impulses, on vivid display in the Iraq war, have become a lightning rod for criticism of U. The Bush administration has been reallocating the resources of the executive branch to focus on emerging powers. In an attempt to ensure that these countries buy into the core tenets of the U. Because these efforts have focused more on so-called low politics than on the global war on terrorism, they have flown under the radar of many observers. But in fact, George W. Bush has revived George H. This unheralded effort is well intentioned and well advised. It is, however, running into two major roadblocks. The first is that empowering countries on the rise means disempowering countries on the wane. To be sure, the EU has made its own bilateral accommodations and has been happy to cooperate with emerging countries in response to American unilateralism. But European states have been less willing to reduce their overrepresentation in multilateral institutions. A coalition of the skeptical, which includes states such as Argentina, Nigeria, and Pakistan, will make it difficult for the United States to engineer the orderly inclusion of India and China in the concert of great powers. Growing anti-Americanism has revitalized groupings of states traditionally hostile to the United States, such as the Nonaligned Movement. To overcome such skepticism, the United States must be prepared to make real concessions. If China and India are not made to feel welcome inside existing international institutions, they might create new ones -- leaving the United States on the outside looking in. These organizations reflected its dominance and its preferences and were designed to boost the power of the United States and its European allies. France and the United Kingdom had been great powers for centuries; in the s the rules of the game still accorded them important perquisites. They were given permanent seats on the UN Security Council. Today, the distribution of power in the world is very different. According to Goldman Sachs and Deutsche Bank, by , the annual growth in combined national income from Brazil, Russia, India, and China -- the so-called BRIC countries -- will be greater than that from the United States, Japan, Germany, the United Kingdom, and Italy combined; by , it will be twice that of the G-7 the group of highly industrialized countries. These trends were already evident in the s -- and the end of the Cold War presented an opportunity to adapt international institutions to rising powers. At the time, however, Washington chose to reinforce preexisting arrangements. The macroeconomic policies known as the Washington consensus became gospel in major international financial institutions. The Clinton administration had good reasons for not doing more. Remaking international institutions is a thankless task that requires holders of power to voluntarily cede some of their influence. There was no urgent need to undertake it in the s: China and India were rising, but their great-power status still seemed a long ways off. Even minor shifts in long-standing U. The creation of the WTO strengthened the global trade regime. Despite the occasional gripe about American hyperpower, the United States seemed able to legitimately advance its interests through the adroit use of multilateral diplomacy. By and large, American hegemony went unchallenged. These gains, however, came with hidden costs. Many of the rising powers believed that the existing global governance structures stacked the deck against them. China

resented the drawn-out negotiations to enter the WTO. Heading into the new millennium, the fastest-growing economies in the world were nursing grudges toward the United States. In part, changes in personnel motivated this shift: In part, change has been foisted on the administration from the outside world. As Philip Gordon, of the Brookings Institution, pointed out in *Foreign Affairs* last year, failure in Iraq rendered neoconservatism an unsustainable strategy. And Washington-style multilateralism is above all a means to further U. Accordingly, the Bush administration defers to institutions it sees as being effective say, the WTO and has consistently sought the enforcement of multilateral norms and decisions it deems important be they IMF lending agreements or UN Security Council resolutions. But it scorns multilateral institutions that fail to live up to their own stated standards such as other UN bodies. Where existing institutions can be reformed to meet new challenges, we, along with our partners, must reform them. Where appropriate institutions do not exist, we, along with our partners, must create them. The G-7 states took it upon themselves to manage global macroeconomic imbalances in the s. Today, however, even when they meet with Russia as the G-8, they cannot be effective without including in their deliberations the economic heavyweight that is China. Incorporating emerging powers while placating status quo states is no simple feat. But the task should appear less daunting when it is understood that success will benefit ascendant states as much as it will the United States. It will bring ascendant states recognition and legitimacy to match their new power. Granted, they will have to accept a multilateral order built on U. But they -- especially China and India -- have grown phenomenally by doing just that. Now that they are concerned with sustaining their current high rates of economic growth, emerging powers share some interests with the United States on issues such as the security of energy supplies and the prevention of global pandemics. A few years ago, it started to reallocate resources within the U. More recently, it has spearheaded multilateral efforts to integrate China and India into important international regimes. The Defense Department was the first U. It started by moving around U. In , more than , troops were based in 45 countries, half of them in Germany and South Korea, the battlegrounds of the Cold War. To improve troop mobility in the face of ever-changing threats, President Bush announced in August that the number of U. Many of these troops will be based in the United States, but others will be redeployed in countries on the periphery of the new zone of threat: The State Department is also adjusting. Our current global posture does not really reflect that fact. For instance, we have nearly the same number of State Department personnel in Germany, a country of 82 million people, that we have in India, a country of one billion people. It is clear today that America must begin to reposition our diplomatic forces around the world. Washington has also strengthened its bilateral relationships with China and India. Last fall, Washington launched the U. On matters as diverse as dealing with North Korea and Darfur, reigniting the Doha Development Agenda, and consulting with the International Energy Agency, Washington has tried recently to bring China into the concert of great powers. The United States has reached out to India as well. Even though Pakistan is a significant U. In November, the U. Department of Commerce arranged its largest-ever economic development mission to India, expanding the commercial dialogue between the two countries. Last year, they also concluded a bilateral agreement to cooperate on civilian nuclear energy -- a de facto recognition by the United States that India is a nuclear power. Critics of the deal have warned that it threatens the NPT. But the Bush administration argues that India is emerging as a great power, the nuclear genie cannot be put back in the bottle, and because India is a democracy, the genie will do no harm. According to the National Security Strategy, "India now is poised to shoulder global obligations in cooperation with the United States in a way befitting a major power. In some instances, the changes have occurred almost as a matter of course. Similarly, the United States has encouraged China to participate periodically in the G-7 meetings of finance ministers and central-bank governors. Officials from Brazil, India, and South Africa have also been invited to G-7 meetings on occasion, on the theory that, as a recent paper from the Treasury Department argued, "addressing global [macroeconomic] imbalances requires engaging heavily with new actors outside the G. Meanwhile, the

Bush administration has moved toward greater cooperation with emerging powers on other issues as well, especially energy, the environment, and nuclear proliferation. It has encouraged China and India, which are anxious to secure regular access to energy, to work with the International Energy Agency in order to create strategic petroleum reserves. Because its members account for more than half of the global economy, the partnership has the potential to affect global warming more than does the Kyoto Protocol. The United States has also relied on China and India to help halt nuclear proliferation. Reform of the UN Security Council has stalled because the proposals emanating from UN bodies themselves have seemed impractical and the key powers have not been able to agree on which countries merit permanent membership. And opponents of the U. But skeptics should consider that such undertakings only bear fruit over time. The Strategic Economic Dialogue with China, which has received fair to middling reviews so far, has only just started. As with the Structural Impediments Initiative conducted with Japan over 15 years ago, which eventually opened up the Japanese market to U. Another difficulty is that rewriting the rules of existing institutions is a thorny undertaking. Power is a zero-sum game, and so any attempt to boost the standing of China, India, and other rising states within international organizations will cost other countries some of their influence in those forums. These prospective losers can be expected to stall or sabotage attempts at reform. Although European countries are still significant, their economic and demographic growth does not match that of either the emerging powers or the United States. Having been endowed with privileged positions in many key postwar institutions, European countries stand to lose the most in a redistribution of power favoring countries on the Pacific Rim.

THE THIRD WORLD AS A MODEL FOR THE NEW WORLD ORDER By: S.R. Shearer *THE EMERGENCE OF A "CORPORATE-TERRORIST" "NEW WORLD ORDER"* For the past several decades, a New World Order has been emerging.

These creations in particular and liberal internationalism in general, however, were regularly criticized and opposed by American paleoconservative business nationalists from the s on. The United Nations was designed in by US bankers and State Department planners, and was always intended to remain a free association of sovereign nation-states, not a transition to democratic world government. Thus, activists around the globe formed a world federalist movement , hoping in vain to create a "real" new world order. Wells went further than progressives in the s, by appropriating and redefining the term "new world order" as a synonym for the establishment of a technocratic world state and of a planned economy. The threat of "Godless communism", in the form of a state atheistic and bureaucratic collectivist world government, demonized as the "Red Menace", therefore became the focus of apocalyptic millenarian conspiracism. The Red Scare came to shape one of the core ideas of the political right in the United States, which is that liberals and progressives , with their welfare-state policies and international cooperation programs such as foreign aid , supposedly contribute to a gradual process of collectivism that will inevitably lead to nations being replaced with a communist one-world government. This right-wing anti-globalist conspiracism fuelled the Bircher campaign for US withdrawal from the UN. American writer Mary M. Davison, in her booklet *The Profound Revolution*, traced the alleged New World Order conspiracy to the establishment of the US Federal Reserve in by international bankers, whom she claimed later formed the Council on Foreign Relations in as a shadow government. At the time the booklet was published, many readers would have interpreted "international bankers" as a reference to a postulated "international Jewish banking conspiracy" masterminded by the Rothschilds. Thus, after the fall of communism in the early s, the main demonized scapegoat of the American far right shifted seamlessly from crypto-communists , who plotted on behalf of the Red Menace, to globalists, plotting on behalf of the New World Order. The relatively painless nature of the shift was due to growing right-wing populist opposition to corporate internationalism , but also in part to the basic underlying apocalyptic millenarian paradigm, which fed the Cold War ca and the witch-hunts of the McCarthy period [14] s. Bush described his objectives for post-Cold War global governance in cooperation with post-Soviet states. Now, we can see a new world coming into view. From the midâ€™s on, the worldwide appeal of those subcultures transmitted New World Order conspiracism like a " mind virus " to a large new audience of seekers of stigmatized knowledge. Fight the Future are often cited as notable examples. These declarations had the unintended consequence of providing fresh fodder for New World Order conspiracism, which culminated in talk-show host Sean Hannity stating on his Fox News Channel program Hannity that the "conspiracy theorists were right". The following is a list of the major ones in roughly chronological order: In many contemporary Christian conspiracy theories, the False Prophet will be either the last pope of the Catholic Church groomed and installed by an Alta Vendita or Jesuit conspiracy , a guru from the New Age movement , or even the leader of an elite fundamentalist Christian organization like the Fellowship , while the Antichrist will be either the President of the European Union , the Secretary-General of the United Nations , or even the Caliph of a pan-Islamic state. Conspiracy Theories and End-Times Paranoia. Hughes argues that "New World Order" rhetoric libels the Christian faith, since the "New World Order" as

defined by Christian conspiracy theorists has no basis in the Bible whatsoever. Furthermore, he argues that not only is this idea unbiblical, it is positively anti-biblical and fundamentally anti-Christian, because by misinterpreting key passages in the Book of Revelation, it turns a comforting message about the coming kingdom of God into one of fear, panic and despair in the face of an allegedly approaching one-world government. Gomes, caution Christian fundamentalists that a "spirit of fear" can distort scripture and history through dangerously combining biblical literalism, apocalyptic timetables, demonization and oppressive prejudices, [27] [28] while Camp warns of the "very real danger that Christians could pick up some extra spiritual baggage" by credulously embracing conspiracy theories. Over the years a number of allegations and conspiracy theories have been directed towards Freemasonry, including the allegation that Freemasons have a hidden political agenda and are conspiring to bring about a New World Order, a world government organized according to Masonic principles or governed only by Freemasons. Despite the fact that Taxil admitted that his claims were all a hoax, they were and still are believed and repeated by numerous conspiracy theorists and had a huge influence on subsequent anti-Masonic claims about Freemasonry. Freemasonry, which promotes rationalism, places no power in occult symbols themselves, and it is not a part of its principles to view the drawing of symbols, no matter how large, as an act of consolidating or controlling power. McKeown argues that the accusations ignore several facts. Firstly, the many Grand Lodges are independent and sovereign, meaning they act on their own and do not have a common agenda. The points of belief of the various lodges often differ. Secondly, famous individual Freemasons have always held views that span the political spectrum and show no particular pattern or preference. As such, the term "Masonic government" is erroneous; there is no consensus among Freemasons about what an ideal government would look like. The movement consisted of advocates of freethought, secularism, liberalism, republicanism, and gender equality, recruited from the German Masonic Lodges, who sought to teach rationalism through mystery schools. In , the order was infiltrated, broken up and suppressed by the government agents of Charles Theodore, Elector of Bavaria, in his preemptive campaign to neutralize the threat of secret societies ever becoming hotbeds of conspiracies to overthrow the Bavarian monarchy and its state religion, Roman Catholicism. The Illuminati were accused of being subversives who were attempting to secretly orchestrate a revolutionary wave in Europe and the rest of the world in order to spread the most radical ideas and movements of the Enlightenment—anti-clericalism, anti-monarchism, and anti-patriarchalism—and to create a world noocracy and cult of reason. During the 19th century, fear of an Illuminati conspiracy was a real concern of the European ruling classes, and their oppressive reactions to this unfounded fear provoked in the very revolutions they sought to prevent. American evangelist Gerald Burton Winrod and other conspiracy theorists within the fundamentalist Christian movement in the United States—which emerged in the s as a backlash against the principles of Enlightenment secular humanism, modernism, and liberalism—became the main channel of dissemination of Illuminati conspiracy theories in the U. The text purports to be the minutes of the secret meetings of a cabal of Jewish masterminds, which has co-opted Freemasonry and is plotting to rule the world on behalf of all Jews because they believe themselves to be the chosen people of God. The Protocols reflect themes similar to more general critiques of Enlightenment liberalism by conservative aristocrats who support monarchies and state religions. The interpretation intended by the publication of The Protocols is that if one peels away the layers of the Masonic conspiracy, past the Illuminati, one finds the rotten Jewish core. There is general agreement that Russian-French writer and political activist Matvei Golovinski fabricated the text for Okhrana, the secret police of the Russian Empire, as a work of counter-revolutionary propaganda prior to the Russian Revolution, by plagiarizing, almost word for word in some passages, from The Dialogue in Hell Between Machiavelli and Montesquieu, a 19th-century satire against Napoleon III of France written by French political satirist and Legitimist militant Maurice Joly. They speculated that this secret society was working behind the scenes to establish a theocratic "United States of Europe". Politically and religiously unified through the imperial cult of a Merovingian Great Monarch—supposedly descended from a Jesus bloodline—who occupies both the throne of Europe and the Holy See, this "Holy European Empire" would become the hyperpower of the 21st

century. Although it is hard to determine whether the conspiracy-minded actually believe this or are simply trying to sanitize a discredited text, skeptics argue that it does not make much difference, since they leave the actual, antisemitic text unchanged. The result is to give The Protocols credibility and circulation. In his first will, written in at the age of 23, he expressed his wish to fund a secret society known as the Society of the Elect that would advance this goal: Established in , the original goal of the trust fund was to foster peace among the great powers by creating a sense of fraternity and a shared world view among future British, American, and German leaders by having enabled them to study for free at the University of Oxford. To this end, Curtis founded the Royal Institute of International Affairs in June and, with his book *The Commonwealth of God*, began advocating for the creation of an imperial federation that eventually reannexes the U. The Council on Foreign Relations began in with a group of New York academics who were asked by President Woodrow Wilson to offer options for the foreign policy of the United States in the interwar period. Originally envisioned as a group of American and British scholars and diplomats, some of whom belonging to the Round Table movement, it was a subsequent group of New York financiers, manufacturers and international lawyers organized in June by Nobel Peace Prize recipient and U. It is a private organization established to foster closer cooperation among the United States, Europe and Japan. In the s, right-wing populist individuals and groups with a paleoconservative worldview, such as members of the John Birch Society , were the first to combine and spread a business nationalist critique of corporate internationalists networked through think tanks such as the Council on Foreign Relations with a grand conspiracy theory casting them as front organizations for the Round Table of the "Anglo-American Establishment ", which are financed by an "international banking cabal" that has supposedly been plotting from the late 19th century on to impose an oligarchic new world order through a global financial system. Anti- globalist conspiracy theorists therefore fear that international bankers are planning to eventually subvert the independence of the U. Cleon Skousen and New Left Carl Oglesby to substantiate this view, even though Quigley argued that the Establishment is not involved in a plot to implement a one-world government but rather British and American benevolent imperialism driven by the mutual interests of economic elites in the United Kingdom and the United States. Quigley also argued that, although the Round Table still exists today , its position in influencing the policies of world leaders has been much reduced from its heyday during World War I and slowly waned after the end of World War II and the Suez Crisis. Today the Round Table is largely a ginger group , designed to consider and gradually influence the policies of the Commonwealth of Nations , but faces strong opposition. Furthermore, in American society after , the problem, according to Quigley, was that no elite was in charge and acting responsibly. He saw a conspiracy plot that was "international in scope, generations old in planning, and incredibly evil in intent. For more than a century ideological extremists at either end of the political spectrum have seized upon well-publicized incidents The statement, however, is taken at face value and widely cited by conspiracy theorists as proof that the Council on Foreign Relations uses its role as the brain trust of American presidents, senators and representatives to manipulate them into supporting a New World Order in the form of a one-world government. In a 13 November interview with Canadian journalist Benjamin Fulford, Rockefeller countered that he felt no need for a world government and wished for the governments of the world to work together and collaborate. However, the United States Senate rejected membership of the League of Nations, which Wilson believed to be the key to a new world order. Senator Henry Cabot Lodge argued that American policy should be based on human nature "as it is, not as it ought to be. Roosevelt and Winston Churchill during the meeting that would result in the Atlantic Charter , precursor to the Bretton Woods system The term fell from use when it became clear the League was not living up to expectations, and as a consequence was used very little during the formation of the United Nations. He advocated strengthening the central role of the United Nations, and the active involvement of all membersâ€”the Cold War had prevented the UN and its Security Council from performing their roles as initially envisioned. The de- ideologizing of relations among states was the mechanism through which this new level of cooperation could be achieved. Concurrently, Gorbachev recognized only one world economyâ€”essentially an end to economic blocs. Reinvigoration of the UN peacekeeping role, and recognition that superpower cooperation can and will lead to the resolution of regional conflicts was especially key in his conception of cooperation. He argued that the use of force or the threat of the use of force was no longer legitimate, and that the strong must demonstrate restraint toward the weak. He asked for cooperation on environmental protection , on debt relief for developing countries , on disarmament of nuclear weapons, on preservation of the ABM treaty , and on a convention for the elimination of chemical weapons. At the same time he promised the significant withdrawal of Soviet forces from Eastern Europe and Asia, as well as an end to the jamming of Radio Liberty. Gorbachev described a phenomenon that could be described as a global political awakening: We are witnessing most profound social change. Whether in the East or the South, the West or the North, hundreds of millions of people, new nations and states, new public movements and ideologies have moved to the forefront of history. Broad-based and frequently turbulent popular movements have given expression, in a multidimensional and contradictory way, to a longing for independence, democracy and social justice. The idea of democratizing the entire world order has become a powerful socio-political force. At the same time, the scientific and technological revolution has turned many economic, food, energy, environmental, information and population problems, which only recently we treated as national or regional ones, into global problems. Thanks to the advances in mass media and means of transportation, the world seems to have become more visible and tangible. International communication has become easier than ever before. His speech, while visionary, was to be approached with caution. He was seen

as attempting a fundamental redefinition of international relationships, on economic and environmental levels. His support "for independence, democracy and social justice" was highlighted. But the principle message taken from his speech was that of a new world order based on pluralism, tolerance, and cooperation. Tolerance is the alpha and omega of a new world order. Being a "good Christian" in such a world means being a compliant and docile worker, which, ipso facto, means avoiding membership in unions or worker organizations of any kind; knowing how to say, "Yes sir" and "No sir" to your "Betters;" not being a "complainer;" avoiding welfare even if that translates practically into holding down several jobs at the same time in order to make ends meet - and making your wife and children do the same; not fussing when elections are rigged; not fretting about police brutality or questioning the authorities when your neighbors and loved-ones are hauled "downtown" on trumped up charges, and so forth. That this is all news to you? Noam Chomsky of the Massachusetts Institute of Technology, a dissident American intellect whom the New York Times said is "arguably the most important intellectual alive" today, says that for the past fifty years the evidence as to what Corporate America has been up to in the world at large has been clear enough.
